



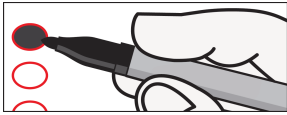

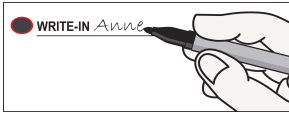

<p>Ballot questions referred by the general assembly by political subdivision are listed by letter, and ballot questions initiated by the people are listed numerically. A ballot question listed as an "amendment" proposes a change to the Colorado constitution, and a ballot question listed as a "proposition" proposes a change to the Colorado Revised Statutes. A "yes/for" vote on any ballot question is a vote in favor of changing current law or existing circumstances, and a "no/against" vote on any ballot question is a vote against changing current law or existing circumstances.</p>	<p>Proposition 114 (STATUTORY)</p> <p>Shall there be a change to the Colorado Revised Statutes concerning the restoration of gray wolves through their reintroduction on designated lands in Colorado located west of the continental divide, and, in connection therewith, requiring the Colorado parks and wildlife commission, after holding statewide hearings and using scientific data, to implement a plan to restore and manage gray wolves; prohibiting the commission from imposing any land, water, or resource use restrictions on private landowners to further the plan; and requiring the commission to fairly compensate owners for losses of livestock caused by gray wolves?</p> <p><input type="radio"/> Yes/For <input type="radio"/> No/Against</p>	<p>City of Montrose Ballot Question 2A:</p> <p>Shall the City of Montrose, Colorado approve an ordinance granting a non-exclusive franchise to Delta-Montrose Electric Association, its successors and assigns, to locate, build, construct, reconstruct, replace, modify, upgrade, uprate, relocate, remove, acquire, purchase, extend, maintain, and operate into, within, and through the City of Montrose, Montrose County, Colorado, all facilities necessary for, or related to, the purchase, transmission, and distribution of electricity to the City of Montrose and the residents, businesses and industry of the City of Montrose, by means of lines, wire, cables, fiber, poles, facilities, equipment or otherwise, over, under, along, across, and through any and all streets, alleys, viaducts, bridges, roads, lanes, and other public ways and places in said City of Montrose, and fixing the terms and conditions thereof?</p> <p><input type="radio"/> Yes/For <input type="radio"/> No/Against</p>
