MONTROSE COUNTY BALLOT QUESTION 1A SHALL MONTROSE COUNTY TAXES BE INCREASED \$7,900,000 ANNUALLY BEGINNING IN 2008 AND BY SUCH AMOUNTS AS ARE RECEIVED IN ANY YEAR THEREAFTER BY THE IMPOSITION OF A 1% COUNTYWIDE SALES AND USE TAX TO BE USED EXCLUSIVELY FOR ROAD AND BRIDGE MAINTENANCE AND IMPROVEMENTS; SHALL SUCH TAX COMMENCE ON JANUARY 1, 2008 AND BE IMPOSED AS FOLLOWS: A SALES TAX AT A RATE OF 1% ON THE SALE OF TANGIBLE PERSONAL PROPERTY AT RETAIL AND THE FURNISHING OF SERVICES IN THE COUNTY; A USE TAX AT A RATE OF 1% ON THE STORAGE, USE OR CONSUMPTION IN THE COUNTY OF ANY CONSTRUCTION AND BUILDING MATERIALS PURCHASED AT RETAIL AND MOTOR VEHICLE AND OTHER VEHICLES PURCHASED AT RETAIL ON WHICH REGISTRATION IS REQUIRED; PROVIDED THAT THIS QUESTION DOES NOT AUTHORIZE THE COUNTY TO INCREASE ANY OTHER FEE OR TAX, INCLUDING PROPERTY TAXES; AND SHALL THIS TAX INCREASE CONSTITUTE A VOTER APPROVED REVENUE CHANGE AND EXCEPTION TO THE LIMITS THAT OTHERWISE WOULD APPLY TO THE COUNTY UNDER ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION, COMMONLY KNOWN AS THE TAXPAYER'S BILL OF RIGHTS OR "TABOR"; ALL IN ACCORDANCE WITH THE RESOLUTION ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF MONTROSE COUNTY AND SET FORTH IN RESOLUTION NO. 110-2007?

BALLOT QUESTION 1B SHALL MONTROSE COUNTY TAXES BE INCREASED \$5,200,000 ANNUALLY BEGINNING IN 2008 AND BY SUCH AMOUNTS AS ARE RECEIVED IN ANY YEAR THEREAFTER BY THE IMPOSITION OF A 0.75% SALES TAX TO BE USED EXCLUSIVELY FOR CAPITAL EXPENDITURES OR OPERATIONAL COSTS ASSOCIATED WITH PUBLIC SAFETY ORGANIZATIONS, AS SUCH TERM IS DEFINED IN SECTION 30-11-107.9, COLORADO REVISED STATUTES, INCLUDING THE SHERIFF'S OFFICE, THE REGIONAL DISPATCH CENTER, THE DRUG TASK FORCE, RURAL MEDICAL CLINICS, THE DISTRICT ATTORNEY'S OFFICE, THE JUDICIAL DISTRICT, THE CORONER'S OFFICE, OR ANY OTHER PUBLIC ENTITY DEDICATED TO PROVIDING SERVICES RELATED TO PUBLIC SAFETY, PUBLIC HEALTH, OR EMERGENCY MANAGEMENT AT THE COUNTY OR LOCAL LEVEL, WITH NO LESS THAN 70% OF THE ANNUAL REVENUE OF SUCH TAX BEING DEDICATED TO THE MONTROSE COUNTY SHERIFF'S OFFICE; SHALL SUCH TAX COMMENCE ON JANUARY 1, 2008 AND BE IMPOSED AS FOLLOWS: A SALES TAX AT A RATE OF 0.75% ON THE SALE OF TANGIBLE PERSONAL PROPERTY OF RETAIL AND SERVICES TAXABLE IN THE COUNTY PURSUANT TO THE PROVISIONS OF SECTION 39-26-104, COLORADO REVISED STATUTES, PROVIDED THAT THIS QUESTION DOES NOT AUTHORIZE THE COUNTY TO INCREASE ANY OTHER FEE OR TAX, INCLUDING PROPERTY TAXES; AND SHALL THIS TAX INCREASE CONSTITUTE A VOTER APPROVED REVENUE CHANGE AND EXCEPTION TO THE LIMITS THAT OTHERWISE WOULD APPLY TO THE COUNTY UNDER ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION, COMMONLY KNOWN AS THE TAXPAYER'S BILL OF RIGHTS OR "TABOR"; ALL IN ACCORDANCE WITH THE RESOLUTION ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF MONTROSE COUNTY AND SET FORTH IN RESOLUTION NO. 109-2007?

SHALL MONTROSE RECREATION DISTRICT DEBT BE INCREASED UP TO \$5,000,000, WITH A MAXIMUM REPAYMENT COST OF UP TO \$6,895,000, AND SHALL DISTRICT TAXES BE INCREASED UP TO \$585,000 ANNUALLY FOR THE PURPOSE OF CONSTRUCTING, REMODELING, AND MAKING ADDITIONS TO THE AQUATIC CENTER WHICH MAY INCLUDE, BUT ARE NOT LIMITED TO, THE FOLLOWING: CONSTRUCTING MULTIPURPOSE PROGRAMMABLE SPACES TO INCLUDE CLASSROOM(S), MULTI-PURPOSE ROOM(S), GYMNASIUM(S), AND A SUSPENDED WALKING/JOGGING TRACK; CONSTRUCTING AUXILIARY SERVICE AREAS INCLUDING LOBBY, FRONT DESK, STORAGE AREAS, AND BATHROOMS; AND REMODELING THE EXISTING FACILITY TO CONVERT THE UPSTAIRS BALCONY TO A FITNESS EXERCISE AREA, TO MODIFY THE WOMEN'S LOCKER-ROOM LAYOUT TO ALLOW FOR FAMILY CHANGING ROOM(S), AND TO CONVERT THE UPSTAIRS SPACE TO OFFICES, WORKROOM, AND A KITCHENETTE; SUCH DEBT TO CONSIST OF THE ISSUANCE AND PAYMENT OF GENERAL OBLIGATION BONDS, WHICH BONDS SHALL BEAR INTEREST AT A MAXIMUM NET EFFECTIVE INTEREST RATE NOT TO EXCEED 5.85% PER ANNUM, SHALL MATURE NOT LATER THAN THIRTEEN YEARS FROM THE DATE OF ISSUANCE OF THE BONDS, AND SHALL BE ISSUED, DATED AND SOLD AT SUCH TIME OR TIMES, AT SUCH PRICES (AT, ABOVE OR BELOW PAR) AND IN SUCH MANNER AND CONTAINING SUCH TERMS, NOT INCONSISTENT HERewith, AS THE BOARD OF DIRECTORS MAY DETERMINE; SHALL AD VALOREM PROPERTY TAXES BE LEVIED IN ANY YEAR, WITHOUT LIMITATION AS TO RATE AND IN AN AMOUNT SUFFICIENT TO PAY THE PRINCIPAL OF, PREMIUM IF ANY, AND INTEREST ON SUCH BONDS AS THE SAME BECOME DUE; AND SHALL THE EARNINGS ON THE INVESTMENT OF THE REVENUES FROM SUCH TAXES AND THE PROCEEDS OF SUCH BONDS (REGARDLESS OF AMOUNT) CONSTITUTE A VOTER-APPROVED REVENUE CHANGE?
