BALLOT QUESTION 1A

SHALL MONTROSE COUNTY TAXES BE INCREASED \$7,900,000 ANNUALLY BEGINNING IN 2008 AND BY SUCH AMOUNTS AS ARE RECEIVED IN ANY YEAR THEREAFTER BY THE IMPOSITION OF A 1% COUNTYWIDE SALES AND USE TAX TO BE USED EXCLUSIVELY FOR ROAD AND BRIDGE MAINTENANCE AND IMPROVEMENTS; SHALL SUCH TAX COMMENCE ON JANUARY 1, 2008 AND BE IMPOSED AS FOLLOWS: A SALES TAX AT A RATE OF 1% ON THE SALE OF TANGIBLE PERSONAL PROPERTY AT RETAIL AND THE FURNISHING OF SERVICES IN THE COUNTY; A USE TAX AT A RATE OF 1% ON THE STORAGE, USE OR CONSUMPTION IN THE COUNTY OF ANY CONSTRUCTION AND BUILDING MATERIALS PURCHASED AT RETAIL AND MOTOR VEHICLE AND OTHER VEHICLES PURCHASED AT RETAIL ON WHICH REGISTRATION IS REQUIRED; PROVIDED THAT THIS QUESTION DOES NOT AUTHORIZE THE COUNTY TO INCREASE ANY OTHER FEE OR TAX, INCLUDING PROPERTY TAXES; AND SHALL THIS TAX INCREASE CONSTITUTE A VOTER APPROVED REVENUE CHANGE AND EXCEPTION TO THE LIMITS THAT OTHERWISE WOULD APPLY TO THE COUNTY UNDER ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION, COMMONLY KNOWN AS THE TAXPAYER'S BILL OF RIGHTS OR "TABOR"; ALL IN ACCORDANCE WITH THE RESOLUTION ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF MONTROSE COUNTY AND SET FORTH IN RESOLUTION NO. 110-2007?

BALLOT QUESTION 18

SHALL MONTROSE COUNTY TAXES BE INCREASED \$5,200,000 ANNUALLY BEGINNING IN 2008 AND BY SUCH AMOUNTS AS ARE RECEIVED IN ANY YEAR THEREAFTER BY THE IMPOSITION OF A 0.75% SALES TAX TO BE USED EXCLUSIVELY FOR CAPITAL EXPENDITURES OR OPERATIONAL COSTS ASSOCIATED WITH PUBLIC SAFETY ORGANIZATIONS, AS SUCH TERM IS DEFINED IN SECTION 30-11-107.9, COLORADO REVISED STATUTES, INCLUDING THE SHERIFF'S OFFICE, THE REGIONAL DISPATCH CENTER, THE DRUG TASK FORCE, RURAL MEDICAL CLINICS, THE DISTRICT ATTORNEY'S OFFICE, THE JUDICIAL DISTRICT, THE CORONER'S OFFICE, OR ANY OTHER PUBLIC ENTITY DEDICATED TO PROVIDING SERVICES RELATED TO PUBLIC SAFETY, PUBLIC HEALTH, OR EMERGENCY MANAGEMENT AT THE COUNTY OR LOCAL LEVEL, WITH NO LESS THAN 70% OF THE ANNUAL REVENUE OF SUCH TAX BEING DEDICATED TO THE MONTROSE COUNTY SHERIFF'S OFFICE; SHALL SUCH TAX COMMENCE ON JANUARY 1, 2008 AND BE IMPOSED AS FOLLOWS: A SALES TAX AT A RATE OF 0.75% ON THE SALE OF TANGIBLE PERSONAL PROPERTY OF RETAIL AND SERVICES TAXABLE IN THE COUNTY PURSUANT TO THE PROVISIONS OF SECTION 39-26-104, COLORADO REVISED STATUTES, PROVIDED THAT THIS QUESTION DOES NOT AUTHORIZE THE COUNTY TO INCREASE ANY OTHER FEE OR TAX, INCLUDING PROPERTY TAXES; AND SHALL THIS TAX INCREASE CONSTITUTE A VOTER APPROVED REVENUE CHANGE AND EXCEPTION TO THE LIMITS THAT OTHERWISE WOULD APPLY TO THE COUNTY UNDER ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION, COMMONLY KNOWN AS THE TAXPAYER'S BILL OF RIGHTS OR "TABOR"; ALL IN ACCORDANCE WITH THE RESOLUTION ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF MONTROSE COUNTY AND SET FORTH IN RESOLUTION NO. 109-2007?

WITHOUT AN INCREASE IN PROPERTY TAX, OR, THE SALES TAX RATE, SHALL THE TOWN OF NATURITA, COLORADO, BE ALLOWED AN ADDITIONAL 1% SALES AND USE TAX, COLLECTED ON AUTOMOBILES AND CONSTRUCTION MATERIALS, BRINGING THE SALES AND USE TAX TO A 4% UNIFORM RATE, BEGINNING IN 2008, WHICH WILL BE THE FIRST FULL FISCAL YEAR OF INCREASE, AND BY WHATEVER ADDITIONAL AMOUNTS ARE RAISED ANNUALLY THEREAFTER, BY APPROVAL OF THE VOTERS OF ORDINANCE NO. 222, SALES AND USE TAX WOULD BE INCREASED BY 1%.
